**Name: Styrofoam cups and containers**

material used: Expandable Polystyrene (trade name EPS D833B) beads, mixed with a small addition of Zinc Stearate ( 0,3 %) (trade name Zincum 5), products are not printed on food contact side. The inks on the non food contact side are complying with the Commission Regulation (EC) No 2023/2006.

Comply with the legal regulations laid down in 10/2011/EC as well as Regulation (EC) No 1935/2004, both in their relevant versions.

Comply with Commission Directive 2008/39/EC of 6 March 2008 amending Directive 2002/72/EC relating to plastic materials and articles intended to come into contact with food.

When used as specified, the overall migration as well as the specific migration do not exceed the legal limits. The test was performed according to the Commission Regulation EC 10/2011. The materials and raw materials used comply with the Commission Regulation EC 10/2011.
